1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ 2,500 under section 137. These payments are included within 'Other payments' in the Accounting Statement.



Auditor General for Wales' Audit Certificate and report

I report in respect of my audit of the accounts under section 13 of the Act, whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met. My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2022 of:

Auditor General's report

Audit opinion – Qualified

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Annual Governance Statement

In my opinion, the Annual Governance Statement is inconsistent with the Council's governance arrangements for the year

- Assertion 1 – preparation of accounting records. The Council's internal auditors have raised an issue regarding the appropriate accounting treatment of staff costs and asset register valuation. Therefore the Council's Annual Governance system is inconsistent with the Council's internal audit report.
- Assertion 2 – effective financial management. The Council did not comply with its standing orders for the procurement of Christmas lighting.
- Assertion 3 – noncompliance with laws, regulations and codes of practice. The Council has not provided evidence that a budget has been set in accordance with the Local Government Finance Act (1992) and that the precept has been set in line with the budget. The Act requires the Council to take into account its level of reserves when setting its budget requirement. In setting its precept for 2022-23, the Council disregarded its accumulated reserves and therefore, in my opinion, issued an unlawful precept. We recommend that the Council sets a budget in accordance with the relevant regulations and codes of practice.
- Assertion 6 – effective system of internal audit. The Council's auditors have conducted a follow-up audit of previous recommendations and have identified that recommendations remain outstanding. Additionally, the Council's internal audits have re-raised a similar issue present in the 2020/21 internal audit report regarding compliance with standing orders/financial regulations.
